- 1. National Environment Management Authority (NEMA) has allocated funds from its annual budget for the financial year 2023/24 to be used for the acquisition of provision of hotel services under framework contract for two (02) years.
- 2. The NEMA therefore invites sealed bids from eligible bidders for the provision of the above non-consultancy services under five (05) lots;

  - (iii) Lot 3: Western Region
  - (iv) Lot 4: South-Western Region
  - (v) Lot 5: Northern Region
- 3. Bidding will be conducted in accordance with the Open Domestic Bidding procedures contained in the Public Procurement and Disposal of Public Assets Act, 2004, of Government of Uganda. This invitation is open to all eligible bidders.

- 5. A complete set of Bidding Documents in English may be purchased by interested bidders on submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of UGX 100,000 (Uganda Shillings: One hundred thousand only). Interested bidders may obtain a Payment Registration Number from NEMA- Accounts Office and pay cash at any of the Commercial Banks. On presentation of proof of payment to NEMA, the bidding document may then be collected by the prospective bidder or his representative from Procurement & Disposal Unit, 2<sup>nd</sup> Floor, Room 208. No liability will be accepted for loss or late delivery.
